




NOTICE OF PUBLIC SESSION FOR THE WHETSTONE FIRE DISTRICT (WFD)

Speakers are asked to state their name and address for the record. Speakers are limited to a three-minute oral presentation and may submit written comments of any length for Board files. Speak in a courteous and respectful manner to those present. Speakers may address the Board on any issue within the jurisdiction of the Fire Board.
