




NOTICE OF PUBLIC SESSION FOR THE WHETSTONE FIRE DISTRICT (WFD)

Pursuant to A.R.S. §38-431.02, The WFD Board will meet in special session on 28-Jul-21 at 6:00 P.M. The meeting will be held at Whetstone Fire Station #321, 2422 N Firehouse Lane, Whetstone, Arizona 85616. The WFD Board may vote to go into Executive Session on any agenda item pursuant to ARS §38-431.03(A)(3) for discussion and consultation for legal advice with the County Attorney on the matter(s) as set forth in the agenda item. The order of the Agenda may be altered or changed by order of the WFD Board. The following topics and any variables thereto will be subject to Board consideration, discussion, approval, or other action.

Board Members may respond to criticism directed to them, and may ask staff to review a matter or ask that a matter be placed on a future agenda. The Board will not discuss or take action on a matter raised during a call to the Public and is not obligated to comment upon materials or presentations made by the public. Speakers are asked to state their name and address for the record. Speakers are limited to a three-minute oral presentation and may submit written comments of any length for Board files. Speak in a courteous and respectful manner to those present. Speakers may address the Board on any issue within the jurisdiction of the Fire Board.
- 6. **REPORTS AND CORRESPONDENCE** This is a summary of activities of the Fire Chief and administrative staff concerning the operations, strengths, and challenges. The WFD Board may not propose, deliberate or take legal action during the report. Therefore, action taken as a result of these reports will be limited to directing staff to study the matter or scheduling the matter for further consideration and decision at a later date. 
